Reservation in direct recruitments, for various categories and classes of posts on the Establishment with respect to Scheduled Castes, Scheduled Tribes, Economically Weaker Sections (EWS) and other categories shall be in accordance with the orders issued by Hon'ble the Chief Justice from time to time, having due regard to the prevailing policies of the Government.

However, 4% reservation to the differently abled persons shall be provided (as per Government of Himachal Pradesh Instructions dated 22.06.2020) to the following categories of posts at the entry level:

Reservation shall be provided to the candidates:

- (a) Suffering from hearing impairment, provided that such impairment is not of 60 decibel or more, after hearing aid/surgical correction;
(b) suffering from loco-motor disability;

(Note: Person with normal upper limb can also be considered.)

Provided further that the Candidate:

1. should not have any mental retardation of any degree and major mental illness like Schizophrenia or affective disorder and chronic psychosis;
2. should not have any Neurological disorder having impaired higher mental function/cognition and significant speech defect;
3. should have normal vision.)

Only candidates selecting "YES" be allowed to apply online. If selected "No" candidate may not be allowed to submit their online application. **(Upload Certificate)**

If applying under qualification type (c) above, then minimum **4 years' experience** required as System Assistant or Assistant Programmer on higher or equivalent post (**as per Schedule Second Sl. no. 2 of the High Court of Himachal Pradesh Members of Technical Manpower (Computer) (Appointment, Conditions of Service and Conduct) Rules, 2014**). Only candidates selecting "YES" be allowed to apply online. If selected "No" candidate may not be allowed to submit their online application. **(Upload Certificate)**
